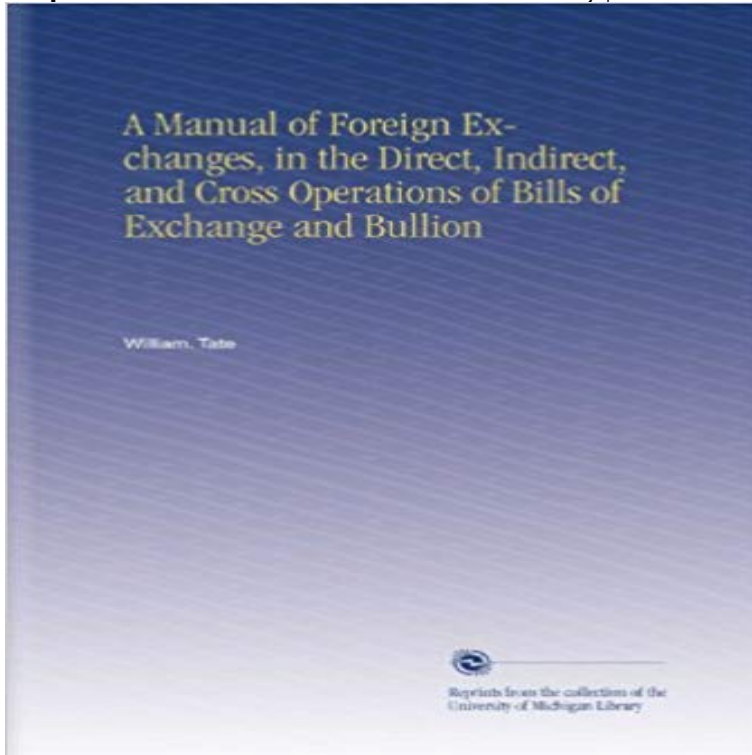

On Wednesday and Saturday the business closes at One.To prevent improper irregular attendance, every Pupil is required to sign the Book of his Class, at his entrance into the School, and it is expected that he will be provided with a note to account for any previous absence.When for misconduct or neglect of his Studies, a Pupil is detained at the Academy beyond the regular Hours, an account is taken of the cause and duration

of his detention, and, if required, the same is transmitted to his Friends. The Academy is opened on Monday and Thursday Evenings from Six to Nine, exclusively for the Instruction of Gentlemen engaged in business during the Day.
