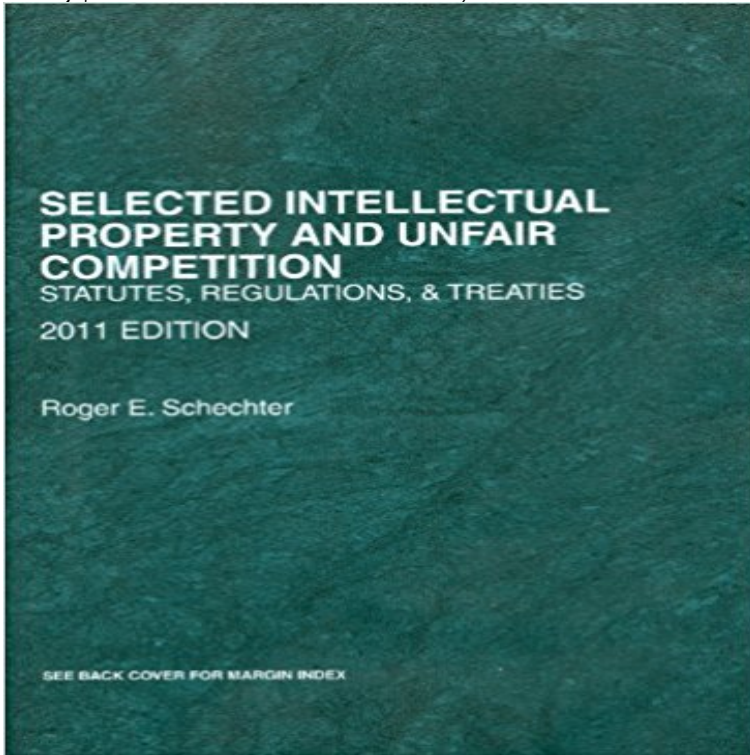


Selected Intellectual Property and Unfair Competition, Statutes, Regulations & Treaties, 2011
