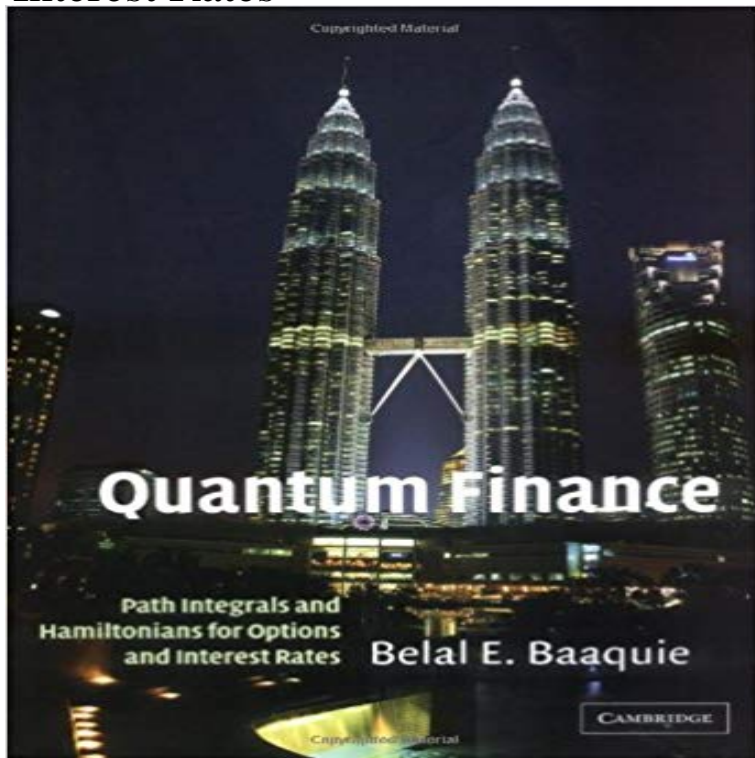


Quantum Finance: Path Integrals and Hamiltonians for Options and Interest Rates
