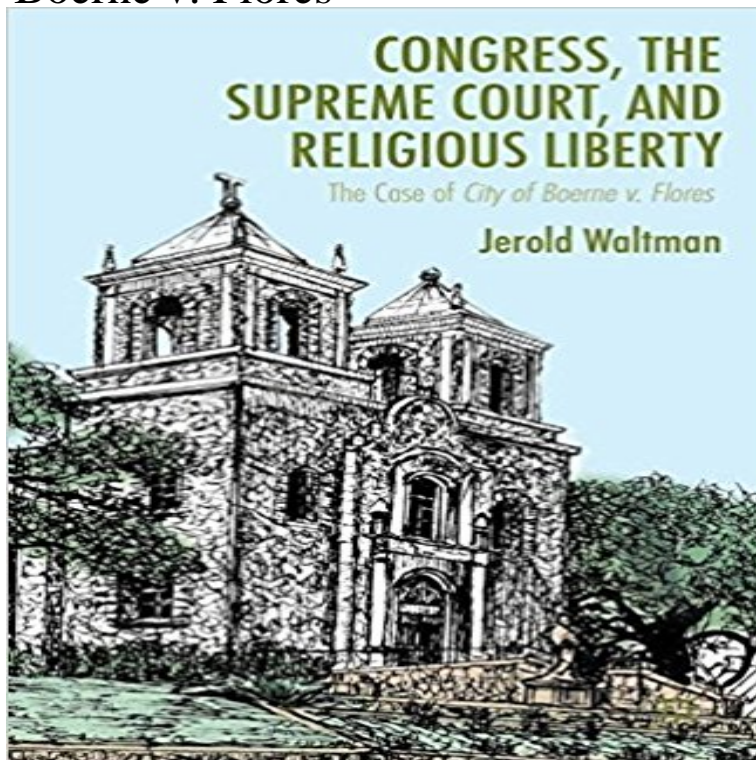


Congress, the Supreme Court, and Religious Liberty: The Case of City of Boerne v. Flores
